Chung Shan Medical University International Student Admission Guide

For the Academic Year of 2025~2026

一、申請期間 Period for Application

2025 年 1 月 10 日至 3 月 31 日 (January 10 to March 31, 2025)

申請入學最多可申請三個系所，但僅能選擇一系所辦理報到及註冊入學。申請兩個系所以上者需分別繳交申請文件，但可合併寄送。

Each applicant can apply no more than three departments or institutes at the same time. Those who apply for two or three departments need to provide the application documents separately, but all the documents can be submitted together in a single packet. If accepted by all the departments applied, however, the student may choose only one program to enroll in.

二、申請方式 Ways to Apply

1. 通訊報名 By mail:

Submit all your required items of things by mail to the Office of Academic Affairs, Chung Shan Medical University (Address: No. 110, Section 1, Jianguo N. Rd., Taichung City 402, Taiwan, R.O.C.) before the application deadline. Please attach the application cover sheet format to the outside of the envelope.

2. 電子郵件 By E-mail

Convert the application documents into a single PDF file in sequence listed on pages 4~5 via email with the subject line "2025-2026 International Student Admission Application - [Applicant's Name]" before March 31, 2025. The total size of the attached files must not exceed 20MB.

Submit all your required items of things in person to the Office of Academic Affairs, Chung Shan Medical University before the application deadline.

三、申請資格 Qualifications for Application

外國學生身分定義：**Definition of International Students**

1. 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。

An individual of foreign nationality, who has never held nationality status from the Republic of China ("R.O.C.") and who does not possess an overseas Chinese student status at the time of their application.

2. 具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者。但擬就讀大學醫學或牙醫學系者，其連續居留年限為八年以上：

An individual of foreign nationality, pursuant to the following requirements and who has resided overseas continuously for no less than 6 years is also qualified to apply for admission. However, an individual who plans to apply for study at a department of medicine or dentistry must have

resided overseas continuously for no less than 8 years.

- (1) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An individual who also is a national of the R.O.C., but does not hold or has had a household registration in Taiwan.

- (2) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior.

- (3) 上述(1)(2)項均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

3. 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。但擬就讀大學醫學或牙醫學系者，其連續居留年限為八年以上。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission. However, an individual who plans to apply for study at a department of medicine or dentistry must reside overseas continuously for no less than 8 years.

4. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。但擬就讀大學醫學或牙醫學系者，其連續居留年限為八年以上。

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission. However, an individual who plans to apply for study at a department of medicine or dentistry must reside overseas continuously for no less than 8 years.

※第2、3、4點所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

※第2、3、4點所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

- (1) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
- (2) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
- (3) 交換學生，其交換期間合計未滿二年。
- (4) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

※The six and eight year calculation period as prescribed in point 2, 3 and 4 shall be calculated from the starting date of the semester (Feb. 1st or Aug. 1st) as the designated due date for the

time of study.

※The term “overseas” as prescribed in point 2, 3 and 4 is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. If the period of continuously living overseas does not conform to an academic year, the amount of time spent overseas shall be calculated as a maximum of 120 days. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with written supportive proof:

- a. Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education.
- b. Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry of Education, and to which the total length of stay is less than 2 years.
- c. Exchange students, whose length of total exchange is less than 2 years.
- d. An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

申請學歷說明：**Educational (or academic) background**

- (1) 符合教育部採認之高中（非本國高中）或在我國境內就讀外國僑民學校或我國高級中等學校附設之雙語部（班）或私立高級中等以下學校外國課程部班畢業者、大學或獨立學院畢業者。申請大學部者需具高中畢業（含應屆畢業生）學歷；申請碩士班者需具學士學位；申請博士班者需具碩士學位。

To apply for entering a bachelor's-degree program, the applicant must have a graduation diploma from an overseas high school or from a foreign high school or from a foreign curriculum department and classes at private senior high schools in Taiwan which has been recognized by our Ministry of Education. To enter a master's-degree program, the applicant must be a holder of a bachelor's degree. To enter a doctor's-degree program, the applicant must be a holder of a master's degree.

- (2) 具有與我國學制相當之同等學力資格者。

Applicants with equivalent qualifications to the academic degree system of Taiwan can apply for admission.

※入學前畢業年級相當於國內高級中學等學校二年級之國外或香港澳門地區同類學校畢業生，其畢業學分應增修二十學分。

Those having completed study at an equivalent foreign or Hong Kong/Macao high school which is equal to the sophomore of a senior high school in Taiwan may apply to the undergraduate program at CSMU, however, according to the Regulations of CSMU, their required number of credits for graduation shall be increased by 20 credits to complete their study.

Application fee: Free.

4. 護照影印本一份及出生證明影印本。（日、韓籍人士可檢附全戶戶籍謄本代替出生證明。）
（依據教育部95.03.09台文字第0950033053號來文，轉知內政部之查詢國籍身分認定程序；請各位申請人務必繳交您的身分證明、生父母身分證明、國籍證明、出生及親子關係證明等相關文件。）

A photocopy of the applicant's passport and a copy of the applicant's birth certificate.

(Japanese and Korean applicants can submit household registration transcripts instead of birth certificates.)

*According to regulations of the Ministry of Education and the Ministry of the Interior, applicants must submit his/her birth certificate, photocopy of parents' identity card and any document that proves their parental relationship. Documents that certify the applicant's nationality are also mandatory.

5. 學歷證明文件及成績單：

Academic credentials and academic transcript

經我國駐外使領館、代表處、辦事處或其他經外交部授權機構（以下簡稱駐外機構）、行政院設立或指定之機構或委託之民間團體驗證之外國學校最高學歷畢業證書或同等學力證明文件及歷年成績單（中、英文以外之語文，應附中文或英文譯本）。

The highest-level diploma and transcript issued by an overseas academic institution. These documents must be authenticated by a ROC embassy, consulate, representative office, another agency authorized by the Ministry of Foreign Affairs (hereinafter referred to as "Taiwan's overseas mission"), or verified by institutes established or appointed by, or through a private agency commissioned by, the Executive Yuan. (These documents should be translated into English or Chinese if they are in other languages.):

- (1) 大陸地區學歷：應依大陸地區學歷採認辦法規定辦理。

Academic credentials from Mainland China: The Regulations Governing the Accreditation of Schools in Mainland China shall apply.

- (2) 香港或澳門學歷：應依香港澳門學歷檢覈及採認辦法規定辦理。

Academic credentials from Hong Kong or Macao: Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macao shall apply.

- (3) 其他地區學歷：

Academic credentials from other areas:

- (3-1) 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

Academic credentials earned at overseas Taiwan schools or Taiwan schools in Mainland China shall be regarded as the same as those at domestic schools with equivalent levels.

- (3-2) 上述(1)(2)項以外之國外地區學歷，應依大學辦理國外學歷採認辦法規定辦理。但

設校或分校於大陸地區之外國學校學歷，應經大陸地區公證處公證，並經行政院設立或指定之機構或委託之民間團體驗證。

Academic credentials referred in the preceding 2 Items shall be subject to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials earned from schools or branches established in Mainland China by foreign schools shall require public notarization in Mainland China and be verified and examined by an institute established or appointed by, or through a private agency commissioned by the Executive Yuan.

6. 推薦函二份（包括一份專業科目教師推薦書及一份中文教師推薦書）。

Two letters of recommendation in English or Chinese, preferably one by a subject course instructor and the other by a Chinese language course instructor.

7. 中文或英文留學計畫書一份。

A Chinese or English “Statement of Purpose” is required to describe your previous academic history, your strength and weakness, your professional interest, your study plan in Chung Shan Medical University, and your future career planning. Some departments have word restriction. Please check the requirement for your department very carefully.

8. 申請人須具備及提供之語文能力證明文件(依申請系所學制之規定)(影本)。

Applicants must possess and submit language proficiency certificates in accordance with the regulations of the applied program or department. (photocopy)

9. 申請系所規定之其它文件。

Other things, if any, as required by the Department or Institute that the applicant intends to enter.

10. 請銀行出具足夠在臺就學之財力證明(最低額度為美金一萬元)，或由政府、大專校院或民間機構提供全額獎助學金之證明

Financial proof by Bank that shows financial sustainability for study in Taiwan (the minimum balance should be equivalent to US\$10,000), or proof of full scholarship provided by a government agency, university, college, or private organization.

- ※ 若存款證明非申請人本人帳戶，另須檢附資助者親筆聲名之財力保證書(附件三)，說明資助者與申請人之關係，並保證負擔申請人在臺就學所有費用。

If the certificate is not in the name of the applicant, a signed sponsorship letter (in Chinese or English) is required (Appendix 3), in which the relationship between the sponsor and the applicant is stated and the support of the applicant's expense for the duration of the applicant's studies in Taiwan is guaranteed.

11. 入學申請具結書（附件四）。

Late, ineligible, or incomplete applications will not be processed. Moreover, no application documents will be returned for any reason. Please make copies for yourself if needed. The application fee is nonrefundable.

An international applicant cannot apply for more than three departments or institutes at the same time. In this case, please make sure to duplicate the application documents. If accepted by the university, the student may choose only one program to enroll in. However, the applications can be submitted together in a single packet.

No double identities (overseas compatriot students and international students): Individuals should decide with which status they wish to apply from the very beginning, as the rules are strict and there are no exceptions. Those who study in Taiwan with double identities (overseas compatriot and international student) will have their recognized student status revoked.

4. 外國學生依教育部「外國學生來臺就學辦法」申請來臺就學，以一次為限。於完成申請就學學校學程後，除申請碩士班以上學程，得逕依本校規定辦理外，如繼續在臺就學者，其入學方式應與我國內一般學生相同。

Upon completion of the course of study, at a school in Taiwan, to which an international student has applied, the student's admission to another school academic level shall be handled in a manner identical to the procedures for admission for local students. An exception is that an application for a master's degree or higher levels of graduate studies can be processed under the procedures of each individual school. International students can only apply with "Regulations Regarding International Students Undertaking Studies in Taiwan" issued by the Ministry of Education once.

No submitted documents should be false or legally invalid. Otherwise, the applicant may be rejected for admission or enrollment, expelled from school after enrollment, or even subject to have his or her degree certificate annulled if the infringement of the regulations is found after his or her graduation.

Each admitted student must complete the registration procedure in time in accordance with the university's regulations. To register, he or she must provide the original copies of his or her passport and diploma (or degree certificate) which is notarized by Taiwan Embassy, Representative Office, or other organizations authorized by Ministry of Foreign Affairs for examination (original documents will be returned after inspection). To delay registration beyond the registration deadline will mean that the student has forfeited his or her eligibility for admission.

During the school time, no international student is allowed to make any household or move-in registration in Taiwan, nor is he or she allowed to change his or her nationality to that of R.O.C., nor is he or she allowed to restore his or her R.O.C. nationality. Any infringement of the regulations will incur the student's loss of the status as an international student and therefore he or she will be expelled from school.

9. 外國學生經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再向本校申請入學，違反此規定並經查證屬實者，取消其所獲准之入學資格或開除學籍。

Once an international student is expelled from a school in Taiwan due to misconduct, poor academic performance, or any legal problem, he or she is not allowed to apply for admission to our university as an international student. Any infringement of the regulation will incur the student's loss of eligibility for admission, and he or she will be expelled from the school anytime the infringement is found.
